Dear Mr Perry

Re: Your Offices' Malicious Intent and Criminal Attempts to deprive me of property, perpetrate and Conceal serious crime

- Thank you for the aforementioned letter dated 25 May 2022, addressed to our Chief Executive Tim Moss, and received by the IPO on 27 May 2022. As a Legal Advisor at the Intellectual Property Office (IPO) Mr Moss has asked me to respond on his behalf.
- 2. Your letter raises a number of distinct issues. I understand my colleagues have already dealt with several of these issues in separate communications. In this letter I propose to deal with the issue of a missing filing receipt for a patent application you call "REF: 'FanTail Ties'TM', which you claim was filed by post on 11 May 2022 and signed for by the Office on 12 May 2022.
 - 3. I am sorry to hear that you have been experiencing difficulties in attempting to file an application for a patent by post. I have spoken with my colleagues in the relevant teams, who inform me that we are unable to locate an application filed at the relevant date bearing your name and/or entitled "REF: 'FanTail Ties'TM'. In your letter of 25 May 2022, you state that a delivery confirmation in relation to your postal item of 11 May is attached. Unfortunately, no delivery confirmation appears to have been included in your letter of 25 May 2022 (received by us on 27 May 2022).
- 4. I am happy to investigate this matter further for you. To assist me in doing this I would ask that if you are in possession of a delivery confirmation for your





postal item of 11 May 2022, that, if convenient, you please provide me with a digital copy to the email address above.

- 5. Alternatively, you may choose to refile your application either via post or digital means.
- 6. If you are unhappy with my response, you can escalate your complaint through our Customer Experience Unit (CEUmailbox@ipo.gov.uk) who will ensure a senior member of staff responds.
