
Sixth Attempt to file Patent application through Online Filing UK Patent Office.




The following pages show proof that I have been unable to file my work in 2022 after I exposed crime being carried out by the Patent Office.

## Readers:

The United Kingdom Patent Office and the people ultimately controlling it are running a black-market in IP rights to cheat and defraud investors and anyone filing IP rights. This is the only conclusion that can be drawn from events that have happened.

I tried filing the above application 5 times on two or three different computers and the UK IPO have criminally blocked me from filing my work in retaliation to exposing their organised crime.

I also sent the application twice by registered post/mail directly to the Chief Executive Tim Moss who refused to respond. Instead he passed it to his legal advisors who then falsified dates on letters to try to make it look like I hadn't replied to issues that had not yet happened at the time they claim they authored the letters, In addition, the applications I sent by registered post were signed for using the name 'PERRY' which is my surname. I have demanded that the Patent Office provide any proof that the person that signed for the letter has the name PERRY because if they don't this is another fraud against me by the Office.

The upshot of the situation is that the Office are doing everything they can to refuse to allow me to file my work to inflict as much emotional pain upon me as they can and to prevent me from restarting my business and career. This is serious Human Rights abuse and constitutes crimes against humanity.

I have used the online filing system to file my work for over ten years and the only problem I have had with it (as far as I can remember) is that at one time the system was so bad it only allowed 5mb of documents to be uploaded and hence it kept failing and crashing. I can assure the reader that there are not any problems with my files, there are not any problems with my computer nor the other 2 to 3 computers I tried filing from; both in the UK and abroad.

I reported this matter to Gwent Police who claimed they didn't have any power over the Patent Office. I also reported my allegations to the Serious Fraud Office again in 2022.

I will be issuing criminal charges in relation to this matter for Malicious Intent, Deception and Evasion of Liability by Deception. I will also be making a claim for an injunction to remove the illegal block that has been imposed.

Their conduct and behaviour is disgraceful, sleazy and very sinister. It undermines investment and my talent as well as the UK economy and is abusive, degrading and humiliating treatment under the Human Rights Act 1998.
